Name of Lesson:

Accessing your Morrisby Profile - Instructional guide for students

Learning Intention:

The purpose of this lesson is to facilitate continued access to the Morrisby Profile tool by students who have completed My Career Insights in Year 9.

Success Criteria:

I can login to my Morrisby Profile.

I understand how to evaluate the information and retake assessment modules where appropriate.

I can use the interactive features to learn about myself and inform my decisions.

Prior Knowledge/ Concepts/ Skills:

Students have completed the My Career Insights program in Year 9 including online profiling and a one-on-one interview with a Careers Consultant.

Students would benefit from having completed:

- Preparatory Lesson Plans My Career Insights (access here)
- Student e-workbook Unpacking your Morrisby Profile (access here)

This lesson has been designed with the intention that students will complete this prior to <u>My Choices – planning for work experience and My Choices – planning for subject selection</u>.

Morrisby student notification:

Any student with a missing aptitude score or scores will see a notification from Morrisby with a prompt to complete the assessment and the estimated time required.

Equipment/ Resources required:

- Internet access
- Computer/laptop/tablet

- Understanding your Morrisby Profile (optional resource) (access here)

Lesson Duration:

20-50 minutes





Lesson Description:

In Year 9 students had the opportunity to complete Morrisby profiling and participate in a one-on-one 'unpack' interview. The Morrisby Profile tool can assist students to understand more about themselves and to research and investigate careers of interest. Students have life time access to their profile and the ability to reshape their profile as they change. This lesson is designed to ensure students have access to the Morrisby Profile tool and understand how to utilise the features prior to undertaking My Choices lessons.

1. Log in to your Morrisby Profile.

If students have forgotten their password, they can reset this themself by following the instructions in the guide.

If they have forgotten their email and password this can be reset by generating a recovery code. See Password Reset/Recovery Codes <u>www.manager.morisby.com</u>.

2. Complete your profile.

Students complete their profile with the option of completing any steps in the 'what to do next' field and/or 'about me' questionaries or by following any prompts to complete missing aptitude assessments.

3. Review your profile.

Aspirations, work style, workplace preference and personality characteristics can change over time. Students have the option of retaking questionnaires if they feel that the results are not an accurate reflection of them.

4. Revise your aptitudes.

Use the 'Understanding your Morrisby Profile' resource (<u>access here</u>) to help students understand their aptitudes pattern and strengths.

There are times when a student's assessment modules may need to be reset so that they can take the assessments again. In year 10, students will have access to retake the assessment modules without needing to be reset.

- **5.** Explore the Morrisby Profile tool including the careers generator and course and subject information.
- **6.** Think about any steps that would be useful in your career planning and use the 'create a next step' tool to assist with your planning.
- 7. Download your Morrisby Profile report. This is a useful resource.
- **8.** Follow the instructions to grant parental access to your profile if you would like to. This might help you continue the conversation with a trusted adult at home.
